3. EXECUTION OF WORK




Fig -1: Workflow | Online registration platform for Training Partner and Assessment body




Fig-2: Wireframe of Signup Screen for the new user

And it includes the undertaking of the organization as well for agreeing to the terms and conditions of SCGJ.




Fig -3: Wireframe of login screen for authentication

This page will route the client to the profile creation page, if their application is not submitted or saved as draft. And if the user has submitted the affiliation form then they can see their application status.




Fig -4: Wireframe of profile screen for registration
