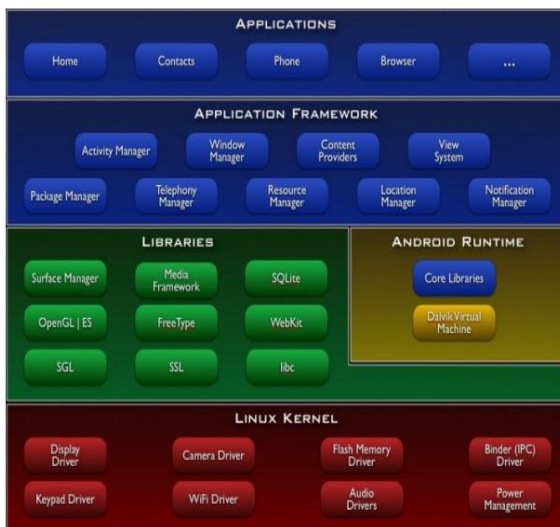


Fig 1: ANDROID FRAMEWORK

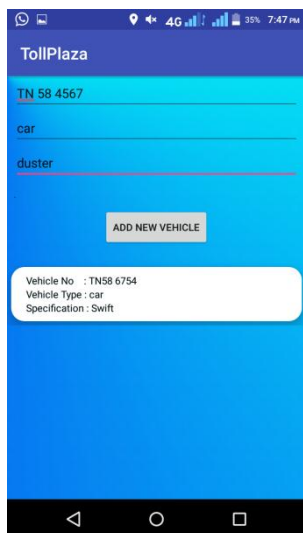


Fig4: VEHICLE REGISTRATION PAGE

- If the vehicle belongs to the authorized person/group, it automatically the toll gate and a predetermined amount is automatically deducted from its account.

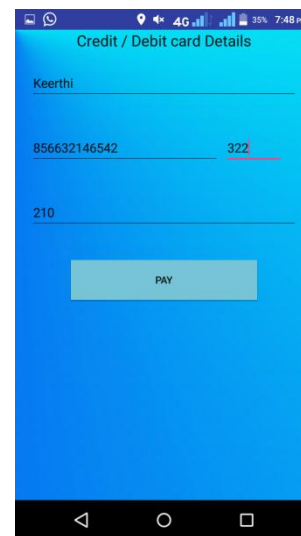


Fig 6: PAYMENT SESSION

- After the confirmation, they permit the vehicle to move, it taken less amount of time and reduce the traffic in toll plaza.

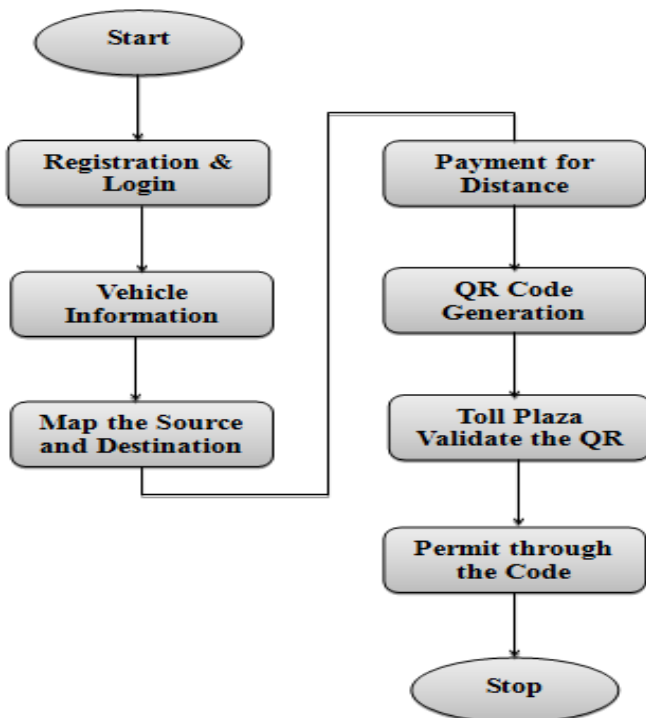


Fig 8: FLOW DIAGRAM
