**Abstract:** Lung disease, a heterogeneous group of parenchymal lung disorder is a great menace to human health. Segmentation is a major step in the estimation of lung disease using Computer Aided Diagnosis (CAD) system. An automatic segmentation of lung field is presented which separates the exact lung region from the background CT slice. After that Thresholding and Morphological method is used for identify or detection of Lung Disease in extracted lung region. Finally the segmented images are applied with feature extraction that helps us to select the relevant attributes for classifying and detecting the injected areas. By enforcing K-Nearest Neighbour approach, the images are classified. Performance indices such as Accuracy, Precision, Sensitivity and Specificity will be studied.

# I. INTRODUCTION

A large number of diseases that affect the worldwide population are lung-related. Therefore, research in the field of Pulmonology has great importance in public health studies and focuses mainly on asthma, bronchiectasis and Chronic Obstructive Pulmonary Disease (COPD) (Holanda et al., 2010; Winkeler, 2006).

The World Health Organization (WHO) estimates that there are 300 million people who suffer from asthma, and that this disease causes around 250 thousand deaths per year worldwide (Campos and Lemos, 2009). In addition, WHO estimates that 210 million people have COPD. This disease caused the death of over 300 thousand people in 2005 (Gold Copd, 2008). Recent studies reveal that COPD is present in the 20 to 45 year-old age bracket, although it is characterized as an over-50-year-old disease. Accordingly, WHO estimates that the number of deaths due to COPD will increase 30% by 2015, and by 2030 COPD will be the third cause of mortalities worldwide (World..., 2014).

For the public health system, the early and correct diagnosis of any pulmonary disease is mandatory for timely treatment and prevents further death. From a clinical standpoint, diagnosis aid tools and systems are of great importance for the specialist and hence for the people's health.

CT images of lungs represent a slice of the ribcage, where a large number of structures are located, such as blood vessels, arteries, respiratory vessels, pulmonary pleura and parenchyma, each with its own specific information. Thus, for pulmonary disease analysis and diagnosis, it is necessary to segment lung structures. It is worth noting that segmentation is an essential step in image systems for the accurate lung disease diagnosis, since it delimits lung structures in CT images. Indeed, image processing techniques can help computer diagnosis if lung region is accurately obtained

#### 1. Image Acquisition:

Images are acquired from Gallery.

#### 2. Preprocessing:

- The objective of the preprocessing phase is to apply possible image enhancement process to obtain the required visual quality of the CT lung image.
- The CT image is in RGB type which is an additive color of red, green, and blue. In preprocessing step, green channel extraction is performed from the RGB image.

### 3. Lung Region Extraction:

- In this step, lung regions extracted from the background CT slice image by using multilevel thresholding method.
- In order to, we get left and right lung region for further lung disease detection.

#### 4. Identification of Affected Lung Side:

- ↓ In this step, affected lung side was identified by using size of lung region.
- First centre point was calculated for extracted both lungs.
- Based on the centre point, each lung region was separated.
- ↓ Next each separated lung size was measured.
- Finally based on size affected lung side was identified.

#### 5. Lung Disease Segmentation:

#### i. Thresholding Method:

Grayscale thresholding is employed to segment the nodule in the CT image. Binary image is called as thresholding image.



Thresholding makes it possible to highlight pixels in an image. Thresholding can be applied to gray scale images or color images. In this discussion gray scale images are used. In Thresholding a pixel intensity value is adjusted, by taking the given value as reference the low intensity pixels will become zero and rest of the pixels will become 1. The result of the Thresholding is a binary image containing black and white pixels.

# 6. Feature Extraction:

## i. Texture Feature:

- In statistical texture analysis, texture features are computed from the statistical distribution of observed combinations of intensities at specified positions relative to each other in the image. According to the number of intensity points (pixels) in each combination, statistics are classified into first-order, second-order and higherorder statistics.
- The Gray Level Co-occurrence Matrix (GLCM) method is a way of extracting second order statistical texture features. The approach has been used in a number of applications, Third and higher order textures consider the relationships among three or more pixels.
- Gray Level Co-Occurrence Matrix (GLCM) has proved to be a popular statistical method of extracting textural feature from images.

#### 7. Classification:

The classification process is done over the segmented images. The main novelty here is the adoption of K-nearest neighbour. KNN classifier is applied over the segmented images and the classification is done.

In the model building part, we construct the AAM and train the LW cost function and GC parameters. In the recognition part, a novel algorithm is proposed for improving the conventional AAM matching method, which effectively combines the AAM and LW methods, resulting in the oriented AAM (OAAM). A multiobject strategy is utilized to help in object initialization. We employ a pseudo-3-D initialization strategy and segment the organs slice by slice via a multiobject OAAM method. For the object delineation part, a 3-D shape-constrained GC method is proposed.

To evaluate the performance of a commercially available CAD system for automated detection and measurement of subsolid nodules. Materials and methods: The CAD system was tested on 50 pure ground-glass and 50 part-solid nodules (median diameter: 17mm) previously found on standard-dose CT scans in 100 different patients. True nodule detection and the total number of CAD marks were evaluated at different sensitivity settings. The influence of nodule and CT acquisition characteristics was analyzed with logistic regression. Software and manually measured diameters were compared with Spearman and Bland-Altman methods.

A ground-glass opacity (GGO) is a pulmonary shadow comprised of hazy increased attenuation with preservation of the bronchial and vascular margins in a high-resolution computed tomography (CT) image. The appearances of GGO nodules on CT images are very different from solid nodules. The current nodules segmentation method does not work well for segmenting tiny nodules and GGO nonsolid or part-solid nodules. The objective of this study is to detect and segment the GGO nonsolid or part-solid nodules.

In this paper we attempt to establish relationships between the parameter values of active contour models and the geometry of the objects/shapes that they are segmenting. Our goal is for users to be able to utilize some basic a-priori knowledge about the geometry of the object in order to automatically select a range of suitable parameter values. We analyse the accuracy of active contour models over multiple series of shapes that exhibit some pattern, such as decreasing number of sides or increasing concavity. We present a novel normalization technique so that the parameter values are of a similar scale. We also carefully design an experimental setup that ensures no bias between different shapes or parameter values.
