


Fig 1: Building Plan.




Fig 2: Elevation.




Fig 3: Isometric view of building.




Fig 5: Imported BIM model in Navisworks Manage




Fig 6: Importing Time Schedule Information from M.S Project.






Fig 8: 4D Construction Simulation for Soil work in Navisworks Manage.




Fig 16: Clash checking in Navisworks.
