This is the admin front page which will be used for online verification of document. It contains registration page for the new user and login page for the existing user.




Fig 4: Shows the admin login for online verification




Fig 5: shows the registration for online verification




Fig 6: User notification to Change Password




Fig 7: Verification Link to Change Password




Fig 8: Document verification




Fig 9: Token generated for verifying Document
