- Record of registered complaints received and the status of the action taken.




Fig 3.1: Anti-Ragging Android System Architecture




Fig 5.2: View Complaints




Fig 5.3: Admin Login




Fig 5.5:Help Desk




Fig 5.6: Complaint Tracking




Fig 5.7: Add Complaint




Fig 5.8: User Home
